In the last issue of our newsletter there was an article which identified the different FSARN elected positions: President-elect, Recording Secretary, Corresponding Secretary, Treasurer, and Nominating Chairperson. If you are not interested in an elected position at this time, we hope you will consider participating on a board committee. These positions are appointed by the President but they need to know of your interest so you will be considered. Committee positions include members and a chair. We are looking for our members to be more active in our chapter so we can continue to set an example for other ARN chapters.

The FSARN committees are: Advisory Board, Bylaws, Communication, Continuing Education, FHA Liaison, Finance, Health Care Policy, Historian, Membership, Newsletter Editor, and Scholarships. These committees are open to any active member of ARN & FSARN. Committee chairs are appointed for a 2 year term after the installation of the newly elected officers at the annual FSARN Conference in May. The committee chair submits reports as required and participates in board meetings, most of which are telephonic.

- Advisory Board Establish guidelines for and develop committee to manage the designated business of the committee. Identify and maintain current membership and communication with representatives of the business and professional community who agree to serve on the Board.
- Bylaws Review Bylaws and keeps them current with ARN. Revisions are presented to the membership for approval following Bylaw guidelines and changes reported to ARN.
- Communication Develops and maintains a current data base to use for with email communication with members and FSARN Board members. Develop and manage email messages to membership as

designated by the board. Identify resources available to promote FSARN activities and programs. A knowledge and understanding of social medias (Facebook, Twitter, etc.) helpful.

- Continuing Education Maintains/renews provider number with the Florida Board of Nursing. Keeps current Continuing Education Program Application available on web site, reviews applications, submits for approval and enters data after program completed. Maintains accurate records of programs offered according to provider requirements.
- FHA Liaison Maintains current information regarding Florida Hospital Association (FHA) issues and concerns and shares information with board and membership. Contributes article to newsletter with current information, concerns and activity.

As you can see there are many opportunities to get active and support FSARN. Descriptions of the remaining committee positions will be included in the November issue of the newsletter. Committees typically communicate by telephone or email, so minimal time involved for most. Another way to get involved is to support your district as an officer or committee member. We need your help and support and hope you will consider a position with the FSARN Board as either an elected or appointed committee member. We hope this information will help you in making your decision to become an active member of the FSARN Board or a committee.

## FSARN Conference Needs You!

FSARN Conference Committee

Anyone who has attended our conference knows the work that goes on during the event by the committee members. However, there is a lot that goes on "behind the scenes" that many members are not aware of. The committee requires assistance throughout the year to prepare a rewarding educational event, while maintaining the quality and diversity that the members have come to expect. The conference committee needs volunteers to help during the year with the preparation and some after event tasks. We know there are many of you that can provide a few hours here and there to help the committee chairs, so we have decided to provide some committee information. Each of the sub-committees has a chair and they have listed the basic tasks for their committee. We ask that you read the information and see where you might be able to assist the conference committee.

**Education Committee** - responsible for selecting topics and confirming speakers, sending speaker letters, obtaining required credentials and submitting speaker information and program for continuing education approval, In addition, they prepare the conference brochure for dissemination, coordinate speaker introductions, compile evaluation data and sending speaker thank you letters.

**Poster Committee-** responsible for announcing a "Call for Abstracts", reviewing submissions, notifying accepted poster presenters with requirements, getting credentials for submission for continuing education approval, and sending thank you letters post conference. **Vendor Committee** – responsible for getting exhibitors for the conference, preparing Vendor agreement, (set deadlines and fees omit), and sending confirmation letters with exhibitor information, making arrangements with Drayage company and preparing floor

**Publicity** – responsible for all email Blasts related to conference activities, keeping Data base current, generating additional contacts for data base, etc, sharing information with Web Managers

using Constant Contact, web site and social medias to promote activities, arranging for advertizing with other professional groups to promote conference.

**Hotel Liaison** – Negotiates with hotel on contract, prices, menus, room block and all hotel related issues.

**Conference Treasurer** – responsible for managing conference account and attendee registration including making badges, preparing attendee sign in sheet daily and sign in sheets for CE's

On Site Registration – responsible for registration beginning Wednesday evening through Friday morning including making sure attendees sign in daily for CE's, making sure conference bags are prepared for attendees, arranging for staffing of registration desk, contacting scholarship recipients to provide assignments for working at the conference, providing attendees with name badges, arranging for distribution of records, coordination of supplies needed at registration including lap top computer, printer, extra name badges are available, office supplies are available.

**Silent Auction** – responsible for generating donations for the Silent Auction through District and company donations, monitoring the auction during the conference, announcing winners and collecting payments.

As you can see there is plenty to do to put on a conference. Many hands make light work. ## Career Corner

#### KINSHIP CARES INITIATIVE

Imagine getting an urgent telephone call from out of state advising your four grandchildren or your nieces and nephews were being placed into foster care unless you come and take them to live with you. Most of you would get on an airplane and rescue those children. But then what do you do next? They have no health insurance; some have medical conditions, the children need immunizations, and consent papers to be registered in a local school, along with needing to be fed and clothed. Many of us wouldn't know where to start. The Kinship Cares Initiative (KCI) of Broward Health in part provides advocacy services for these families educating and empowering caregivers to be proactive in addressing the needs of their families.

"Kinship care" is defined as the provision of full time care of a child by relatives (usually grandparents) or other adults who have a bond with child (Child Welfare League of America, 2007). Kinship caregivers face a variety of stressors including strains on family recourses, legal issues, healthcare and other social challenges. The KCI was created to assist kinship families residing in Broward County to navigate the various healthcare systems throughout the county. Kinship caregivers can find accessing services to be daunting and overwhelming and without help, they often in crisis, seek care at area hospital emergency rooms.

As the Healthcare Navigator/Case Manager, working alongside other KCI staff, it is our role to help kinship families find answers to their basic healthcare needs; thus improving their overall quality of life.

In our community and nursing organizations, we find that many grandparents, relatives and even friends are raising children that are not their own. They find themselves in a new role as parents or guardians to their grandchildren or other extended family members. Various reasons play a major role in this lifestyle upheaval that range from the biological parent (s) drug addiction, incarceration, debilitating illnesses, death of a parent or parents, unemployment, abandonment, abuse, homelessness and more.

In partnership with schools, social and health service agencies throughout the county, we receive referrals from school counselors, judicial staff, healthcare and social service professionals, and other individuals. After an initial telephone assessment with the caregiver of this blended family, a home visit is completed where the family's healthcare needs are further assessed and care plans are developed to ensure appropriate services are arranged.

KCI staff work to assure the healthcare needs are fully addressed for the kinship families who seek services through our program. These services may range from assisting the kinship caregivers to apply for health insurance for themselves or for the children in their care; ensure each family member is established with a medical home or a primary care physician; arrange or ensure appointments are made for wellness examination, including dental, vision and/or specialty care as well as immunization updates. Oftentimes KCI staff work tirelessly to get theses services provided at no or minimal cost.

Ongoing health and nutritional education is provided to family members with chronic illnesses such as diabetes, hypertension and asthma. As the healthcare navigator, I sometimes attend the initial medical appoinments with the family to enhance communication with the physician, and to ensure treatment plans are followed correctly by the family member.

The KCI also links kinship families to social service programs and organizations as many are overwhelmed with how to financially make ends meet especially given the additional cost incurred with now having to raise small children. Caregivers are so preoccupied with making sure the children do not go into foster care that they often do not give consideration to the expense of a child's well being.

We have made well over two hundred referrals on behalf of families we serve for legal, housing, counseling, and transportation assistance, as well as other support services. Families often express their gratitude and feel less intimidated and more empowered to take control of their health and economic situation after having received assistance from the KCI.

The Kinship Cares Initiative has experienced great success over the four years of service to the Broward County kinship community. Listed below are four unique stories of kinship families we are most proud of having helped.

An 82 year old grandmother raising her two teenage grandsons after losing both parents within two months of each other while living in the Bahamas. This kinship family is one of the first members to be enrolled in the KCI. The children came to live with grandmother because other family members were not able or willing to take them in. Both the grandmother's and the children's healthcare and social service needs were great. KCI staff were able to obtain healthcare coverage for the children, establish them with a medical home within the Broward Health's network, schedule and attend doctors' appointments with the family, and took the leadership in finding and scheduling a medical examination with a civil surgeon in order for the children to receive their green cards. Staff also assisted with social services linkages for housing, transportation, counseling and other basic essentials. Sadly, the children's grandmother died recently; however, the children were taken in by their grandmother's long term friend and the one of the children needing major surgery is recovering in the hospital and the family is receiving grief counseling.

A middle-aged couple raising eight children, one of which is a grandchild and all below the age of twelve, on a one-salary income; residing in a two bedroom apartment. Several of the family members were uninsured and in need of medical care and social services. The KCI has been providing services for this family for over a year assisting the family to obtain health insurance for all of the children. KCI scheduled wellness exams, established medical homes, and was instrumental in qualifying and relocating the family into a new community townhouse complex. The family was able to move into a five-bedroom reduced rent townhouse. The KCI linked the family with several other organizations for assistance including a local church that provided dozens of Christmas gifts for the children.

A middle-aged grandmother raising her two year old grandchild who has a cancerous tumor intricately located in her lower spine, with whom doctors have said they done all medically possible; chemotherapy did not work. The grandmother does not work because of the frequency of the child's medical treatment and physical therapy appointments. The grandmother is challenged with her own health problems, including an elevated high blood pressure, which was being neglected because of her fixation on the child's well being. The KCI obtained health insurance for the caregiver; the child was already receiving care when the family enrolled in the program. Medical treatment, assistance with medication cost, and occasional transportation to doctors' appointments was provided. Multiple social services were arranged to assist the family.

A middle-aged mother raising her biological daughter who has a heart condition, and three other teenage relatives, one of whom is blind in one eye sustained in a playful accident with a friend. None of the family members were insured. The child received emergency care for the initial accident but no follow up care was provided because the caregiver could not afford the medical cost. The KCI was able to obtain health coverage several members of the family, but unfortunately, due the child's immigration status, he is currently not qualified for any affordable insurance plan. However, staff was successful in connecting the family to the Lion's Club who has agreed to pay for the vital surgery the child needs to possibly regain his vision.

Kinship care is the fastest growing form of in-home living arrangements for children whose parents cannot care for them. According to the U.S. Census Bureau, 2010, the number of children in the United States living in grandparents headed homes today is 4.9 million; almost one million of those children are being raised by grandparents alone; and 1.9 million children are currently being raised by relatives other than grandparents. Also based on current census data, an estimated 9,774 kinship families, with 15,345 kinship children and 11,045 kinship caregivers, reside in Broward County in 2010. The KCI has served some 700 kinship families including nearly 1000 children.


